#### **Academics:**

What issues do you believe FISD needs to address in its academic programs and what changes would you recommend?

I think we need to return the primary focus of the k-12 educational system to teaching a knowledge-based curriculum that allows students to build the fundamental skills needed to think independently, critically and have opportunities in life to succeed. I would be an advocate for removing the emphasis on continually evaluating and surveying the student's emotional status as this takes instruction time away from the academic subjects that matter in developing a child for a productive life.

### **Budget:**

What are your thoughts on the current and proposed budget for your school district?

The actual 2021-2022 and the proposed 2022-2023 operating budgets appear to be well thought out, but I would have questions regarding the details behind the budget categories such as 1) Instruction, 2) Curriculum Development & Staff Development, 3) Guidance & Counseling, Evaluation, 4) Instructional Leadership and School Leadership, 5) Social Work Services, and 6) Payments to Fiscal Agents for Shared Service Arrangements.

Bottomline, we need to spend the revenues that we have wisely to the maximum benefit of the educational service that we provide Gillespie County families and students.

As a board member, are there any areas you would consider cutting or adding? How do you determine your budget priorities?

My budget priorities are predicated on what drives the maximum benefit towards a quality education of the child. At the top of that list is being able to hire and retain the best teachers we can for this school district so that they can afford to live here. In order to do this, we may need to take a hard look at the allocation of existing revenues.

# **Transparency:**

First, I would advocate for classroom curriculums to be posted online for all grades giving parents full transparency as to what their child is learning along with transparency around where the school is spending

taxpayer dollars. Any 3<sup>rd</sup> party vendors that the district is considering should be presented to the community before a vote is held along with a full analysis of the basis for the vendor recommendations, and the research of the alternative solutions available and considered. The community needs to be able to understand that the school board trustees and school admistrators are making the best decisions possible in the interest of the students and this community.

What process can be implemented to ensure the trustees are listening and addressing the concerns of their constituents whose children the district serves?

Accountability and transparency to the community in which the FISD school board trustees serve is very important in establishing and maintaining trust and a good working relationship. I would like to see the school board have a section on the FISD website that is focused on community issues and timely updates as to what action the school board is taking or has taken to resolve these issues. Open communication is key to quality relationships, and I think the school board can do better at keeping the community informed.
